# LOCAL LAW #1 & 2

Resident Joe Poplawski submitted his own version of the proposed law adding more definitions and other provisions and requested that some of these be incorporated into the law. He believes that the village is trampling on his rights as a cat owner. His proposal is on file in the clerk's office.

Questioned if the at large definition means if his cat is loose on his property do we consider that at large?

Section 36-3c and d was changed to 36-3 as owner's responsibilities.

Changed 36-5 to include proof of rabies and distemper shots.

Changed 36-9 for penalties and added D- any offense thereafter is \$500.00
