# RESIDENT REQUEST FOR FUNDING CAT BILLS

Mary Devlin requested money for the vet bills she incurred from trapping a cat on Third St. \$401. She would also like money set aside for possibly 3 additional cats that are still at large on Third St. Cost \$120 per cat approximately.

Ms. Devlin is not connected with the Humane Society.

Discussion: Mayor Falci asked if any other municipality had given financial assistance. Ms Devlin said no. Trustee Thomas asked if there was money in the budget for this type of assistance. Clerk noted the money in the budget was for the assistance of the humane society. Trustee Libordi noted that the board's responsibility is public safety and does not believe that we are not capable to do that. We can appropriate money but not for a cause.

Mayor Falci will look into the legality. Not sure the Village can help financially. There is an animal control officer that will capture woodchucks and possibly he would do the same with cats.

# **OTHER**

Ms. Diane Mulkin, 375 First St, would like the following be noted in the village minutes: The new home constructed behind her house had the land raised from what appears to be the property line (the min 10' set back) approximately 24" and down into her property. From the other end of the new house the land has been raised 36". She has spent a considerable amount of money to remedy water problems in her basement. She would like it noted that if there are any problems resulting form the new home, she would like it to be on the record that she brought this information to the board.

Trustee Libordi asked the Code Enforcement officer to contact Mr. Boccia on Cleveland Ave. regarding a property line issue. Mr. Boccia took down a fence that his neighbor Mr. Hoyos attached to Mr. Boccia's garage. When the fence was taken down Mr. Hoyos' dog attacked some of the men working for Mr. Boccia. Trustee Libordi would like to eliminate any possible confrontation between the two neighbors.

Trustee DiRaimondo asked about Zoning Codes. Has anything been done regards to our codes. Mayor Falci would like to hire someone to go over our codes. He noted the article in the Tribune dated October 8<sup>th</sup> regarding the Town Planning board which stated that the board agreed to continue an initiative to revamp the towns zoning laws. The Mayor would like to put on the agenda for next month the revision of the North Hornell zoning codes. Also who will we ask to work on this and what will be the payment for their services.

Trustee Dick is on the Towns Planning board and noted that they have been working on codes for over two years. They have used NYS approved codes from other towns as a template for the towns. It is a tedious and time consuming job. No one on the board is paid for this and they are not paid. Mayor Falci asked CEO Schieder if Mr. Bliss had a list of Villages with approved codes. Mr. Schieder stated that Mr. Bliss had a list of less than 6 Villages that have revamped their codes. Mr. Schieder has been using our codes creating to a multitude of problems. The Mayor would like to find a Village that is similar to ours that could be used as an example.

Trustee Dick informed the board that the NYS DEC passed a law which restricts what you can burn in NYS. This goes into effect on October 14<sup>th</sup>.

He also noted that North Hornell has not adopted the Steuben County Hazardous Mitigation plan. Trustee Dick met with Mark Sprague the County emergency service director and was told that if the Village does not adopt this plan, we cannot get FEMA money. Trustee Dick asked that the Clerk print copies of the plan from the county web site. The copy will be available for Trustees to review for next months meeting.

Trustee Dick read a letter from Hornell Fire Department thanking the Village for the \$1000 donation towards the auto pulse equipment.
