GRANTS

Winola Richards a grant writer at Alfred State College explained procedures for village to obtain grant money. Village needs a strategic plan. Have programs that you can point to; a reason why you are different from the other people who are applying for the same amount of money. For most grant writers, the return rate successful is 30%. Start with a plan for the village and have someone to do the research to find what grants are available.

Ms Richards would be willing to work with a planning committee to make a strategic plan. She charges \$25.00 per hour.
