Mayor Stephen Terry announced that the purpose of the public hearing was to gather comments and question from residents concerning the proposed 2004-05 budgets

He explained the following: We will be purchasing a new plow truck, which will cost around 40 thousand dollars, increased the amount of the fire agreement with the Town to \$30,000, and we will buy a sewer cleaner for approximately \$27,000.

Mayor Terry noted that we would be getting a \$35,000 grant through Senator Kuhl for roadwork on Cleveland Avenue. We have also had a police car donated from Simmons-Rockwell.

Mr. Giles: We are giving the library \$5000.00 and they have now obtained a tax on real property for the library isn't that double dipping?

Mayor Terry: We kept it the same as they said that if the municipalities did not, after the tax levy it would defeat their purpose of keeping the library solvent.

J. Dick: Some of the amount was for a capital project if that is complete they should come back to the board and explain what they need.

Mrs. Giles: Perhaps another year we could re-think it.

R. Giles: What are your going to do with the old police car?

Fire Chief Chick: The fire department would like to have it to transport firemen to Montour Falls for training.

Mayor Terry and Board of Trustees will consider the request.

Mayor Terry adjourned the public hearing at 7:05 P.M.
