Mayor Falci opened the meeting at 7:10 PM.

The Mayor reported that Officer Courteney Kilmer the new part time police officer will be on the force this week. Hopefully this addition will give us the 90 hours of police protection that we have asked for.

Mr. Scheider the CEO has showed progress on his works. The garage on Totten Lane must come down. Hopefully soon. There are other property owners that are will be given appearance tickets.

On May 11th the board will approve the new Fire officers.

Fire fighter Walt Rutski asked for board approval for the fire department to take the trucks to the following parades:

May 16 Dogwood parade in Dansville

May 25 two parades the Hornell Memorial parade and the Arkport Memorial parade. Mayor Falci made a motion to approve the Fire department to go to the three parades, Dansville, Hornell and Arkport. Motion was second by Trustee Libordi and carried. Trustee Dick abstained.

Fire Fighter Rutski turned in the March '09 Treasurers report from the Fire Dept.

The following is an account of that report:

Fire Department President asked for approval for 2 new members to the Department. Katherine and Anthony Harvey. This brings the total count of firefighters to 33.

Motion made by Trustee Thomas to accept Anthony and Katherine Harvey as members of the fire department. Motion second by Trustee Libordi and carried.

Mayor Falci noted that the board will approve the newly elected fire chiefs at the April 27th meeting.

Clerk Libordi reported according to CEO Jim Scheider, New York state gives the board the Village board the authority to set a fee for Fire inspections. There are several commercial facilities that will need to be inspected. At present the Village has no fee schedule. The board questioned if the Village was responsible for inspecting the North Hornell School and McAuley Manor. Trustee Libordi will contact Dan Smith from the City to inquire if they are currently inspecting those buildings.

Trustee Libordi asked that the Village residents be reminded that there is free mulch for residents at the City. Possibly the DPW could use it for Village properties. Also a reminder that May 18, 19 & 20 will be Spring Clean up in the Village.
